to acquire continuous supervision of the wood-based panels production in the scope of formaldehyde emission and carried out an independent external audit, which covered the functioning of quality control system, work of the product quality control laboratory, accuracy of the current tests of emission or content of formaldehyde in the produced wood-based panels. Based on the results obtained (Test report № 229/FC/2016), the Center found that the product subjected to supervision:

in the range of thicknesses $3,00 \text{ mm} \leq A < 12,00 \text{ mm}$

according to Producer statement fulfills requirements of standard:
