and carried out an independent external audit, which covered the functioning of quality control system, work of the product quality control laboratory, accuracy of the current tests of emission or content of formaldehyde in the produced wood-based panels. Based on the results obtained (Test report no 264/HDF/FC/2020-1), the Center found that the product subjected to supervision:
